- 4. **Ethics and permissions.** For empirical work involving people, obtain required permissions or institutional review board (IRB) approval. Maintain confidentiality and informed consent.
- 5. **Deliverables.** Possible deliverables: research paper (4,000–10,000 words), policy brief, annotated statute, model draft law, litigation strategy, training module, dataset with analysis, or presentation with slides and a bibliography.

Constitutional & Administrative Law (1-10)
